Victorian Renewable Energy Auction Scheme

The Victorian Renewable Energy Auction Scheme (VREAS) will support achievement of the Victorian Renewable Energy Targets (VRET).

These targets seek to ensure that 25 per cent of the State's electricity generation comes from renewable sources by 2020, rising to 40 per cent by 2025 and 50 per cent by 2030.

Local Investment Commitments

A suite of programs will be designed to meet the needs of the local community, including the:

- Contribution to Melbourne University as part of the Renewable Energy Research Investment Partnership, involving a; research project into Distributed Network Design and Impact on Communities and research project into Community Renewable Energy Projects.
- Honey Eater Vegetation Screening and Volunteers. FRV has committed to fund an initial two-year pilot partnership with the Regent Honeyeater project (RHEP). FRV will continue to support the RHEP via direct support for ongoing plantings, either locally or within the broader region.
- Development of a local employment and procurement program as per the Local Investment Development Plan (LIDP) for the project.
- Enrolment to the GO TAFE Traineeship Program to ensure the highest number of suitably-qualified local candidates are available for ongoing positions at WSF.
- Exploration of supporting Benalla Sustainable Futures Group – Zero Emissions which is a local volunteer-run organisation, delivering key aspects of their three-point plan to position Benalla as one of the first 'zero net energy' towns.

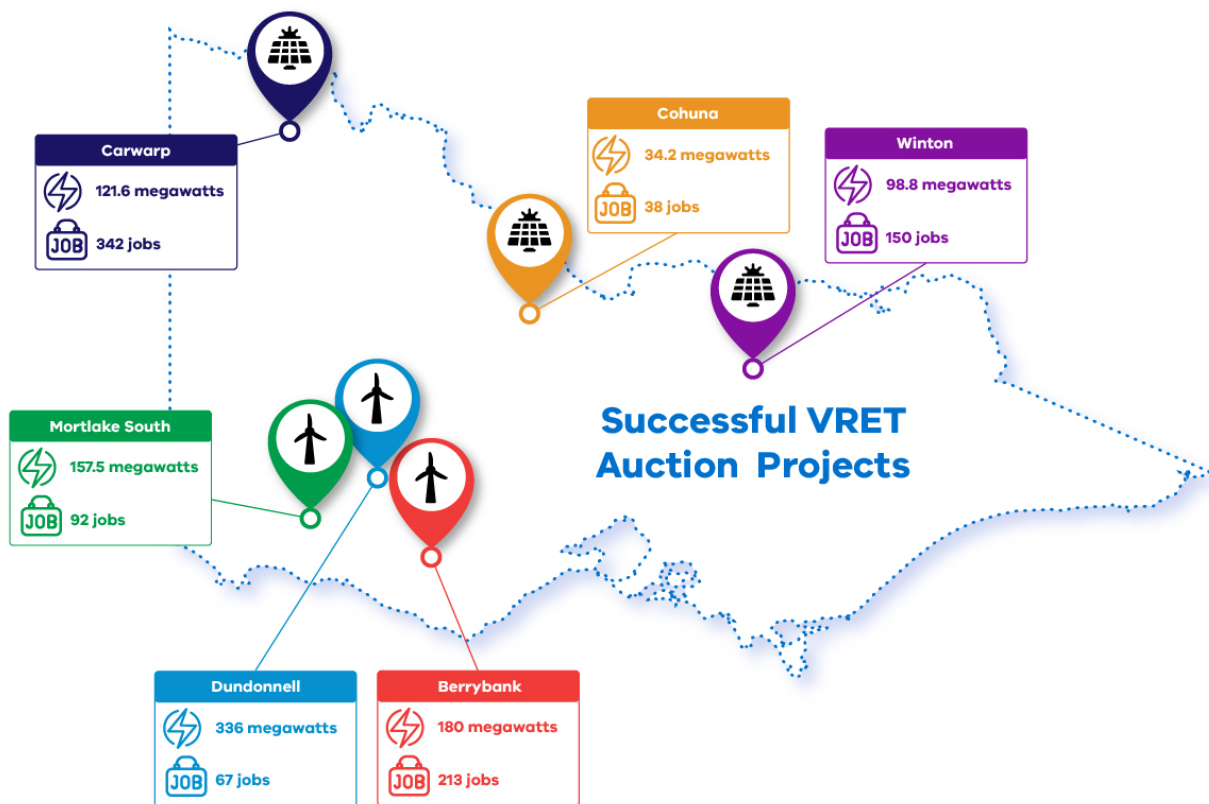
